CONDITIONS OF USE

1. The Scholar Bus Travel Pass can be used between the inclusive dates shown and between valid points.
2. The Travel pass is valid for travel on Mondays to Fridays during term times to and from the School or College stated.
3. The holder may also use the pass, as a Child Explorer during term times after 16:00. Travel will also be allowed after 09:00 on Saturdays and Sundays and during the half term holiday(s) while the pass is valid.
4. The pass holder may also use the Travel pass after 09:00 during the holiday period following the term for which the pass has been issued. (except during the summer vacation period)
5. Annual passes will also be valid for travel after 09:00 during the summer vacation period.
6. This Travel pass must be shown to the driver on every journey. If no pass can be produced at the time of travel then the ordinary single fare must be paid. Altered, defaced or damaged tickets will not be accepted and will be withdrawn.
7. The pass is NOT transferable and does not give the holder priority over other passengers. It is issued subject to the rules and regulations of the company. Not valid on train services.
8. A replacement pass will not be provided in the event of it being lost or stolen. A new pass will need to be purchased.

First Devon & Cornwall Limited has teamed up with Travel & General Insurance Company plc to provide you with insurance for your scholars bus travel pass. The policy provides cover for two replacement passes if the pass is accidentally lost, stolen or damaged.

First Devon & Cornwall Limited will not provide a replacement for lost, stolen or damaged passes unless you have purchased the insurance. If you do not purchase the insurance and your pass is lost, stolen or damaged you will be required to purchase a new pass.

To be eligible for the policy you must be a resident of or have a residential address and resided in the United Kingdom or the Republic of Ireland for at least 6 months of the last 12 months and be registered with a general practitioner.

You have 14 days to return the policy documentation and receive a full refund providing you have not yet travelled or made a claim.

COVER EXPLAINED

Ticket replacement

We will replace your ticket if it is accidentally lost, stolen or damaged during the period of insurance. You are entitled to two replacement tickets under this insurance, after which an additional premium is required in order to reinstate cover.

Personal accident

Provides a payment to you or your legal representative if during your journey you sustain bodily injury caused by accidental, external, violent and visible means and within 12 months you suffer death or total and permanent disablement.

Personal liability

Covers amounts for which you are legally liable in a personal capacity to pay for accidents happening during your journey resulting in bodily injury or death to third parties (not being a member of your immediate family) and damage to their property.

PERIOD OF INSURANCE

Cover under Section A applies only between the pass start and expiry dates. Cover under Sections B and C of the policy only applies during the pass start and expiry dates and only for the duration of your journey on a First Devon & Cornwall Limited bus. Cover does not apply when you are not travelling on a First Devon & Cornwall Limited bus.

THE INSURERS

This policy is underwritten by Travel & General Insurance Company plc and First Devon & Cornwall Limited is an Appointed Representative of Travel & General Insurance Company plc, both companies are authorised and regulated by the Financial Services Authority (FSA).
